Principal Duties and Responsibilities:	1) Knowledge of the Muscogee (Creek) Nation Code Annotated, Citizenship/Census, Title 7 establishing the citizenship roll and making provisions for enrollment of tribal citizens. 2) Knowledge of the Bureau of Indian Affairs rules and regulations for issuing CDIB cards. 3) Operations of the enrollment database to issue new/replacement citizenship ID card with the signature photo, and detailed enrollment information. 4) Acts as a receptionist in greeting the public 5) Assists the Enrollment Specialist with various tasks of the enrollment process. 6) Review all submitted documentation for accurate data/facts for certification purposes. 7) Verify that the No Dual Enrollment policy is strictly enforced. 8) Travel as needed to perform remote enrollment functions. 9) Issue and receive CDIB & Citizenship applications from prospective citizens. 10) Answer all enrollment questions via telephone, walk-in visitors, and correspondence. 11) All other duties as assigned.

MCN Policy Requirements:

All applicants must pass a drug test before beginning work. Any candidate who fails or refuses a drug test shall be withdrawn from employment consideration.

Medical Marijuana License Holder Protection and Non-Discrimination

A. Unless a failure to do would cause The Muscogee (Creek) Nation to imminently lose a monetary or licensing related benefit under federal law or regulations and with the exception of employees whose jobs are safety sensitive or primary job function is driving, The Muscogee (Creek) Nation shall not discriminate against a person in hiring, termination, or imposing any term or condition of employment or otherwise penalize a person based upon either: a. Solely, the person's status as a medical marijuana license holder; or b. Solely, the results of a drug test showing positive for marijuana and its components. B. Employees that are medical marijuana card holders shall not use, possess or be under the influence while at their place of employment or during hours of employment.
