



Native Christmas Market - Riverwalk, Jenks, Oklahoma Vendor Requirements/Rules/Regulations Saturday, November 23, 2023 - 1:00 p.m. to 7:00 p.m.

1. Vendor Requirements

- Must be an enrolled citizen of federally-recognized tribe (attach copy of verification with application).
- Complete vendor application and Temporary Vendor's License application.
- Arts, Crafts, and any other handmade items are strongly encouraged and shall be given priority over all other items including commercial items.
- This is not a flea market.
- Vendors must be set up and operational for the duration of the event.
- There is a \$20 set up fee. Each vendor will receive one table. Please supply your own canopy.
- Deadline, Friday, November 15th.

2. Vendor Space Rules and Regulations

- Space is limited and is granted on a first-come, first-served basis.
- Vendor spaces are located throughout Riverwalk Crossing.
- We provide one table. Any other items required for set-up are the responsibility of the vendor.
- Electrical outlets are available. Please note on application if you need access.
- Vendors may begin set-up no earlier than 11:30 AM. Be operational 1:00 PM 7:00 PM.
- Mind the schedule and adhere to rules out of respect for patrons, fellow vendors, and event staff.
- Please note, this is an outside event. Feel free to bring lights and decorate your space to add to the festive atmosphere at Riverwalk.

3. Temporary Vendor Tax License Fee

- 4. Muscogee (Creek) Nation citizens are exempt of fees with proof of enrollment.
- 5. All others pay a fee of \$50 made payable to MCN Tax Commission due upon submission of application.
- 6. Information on the Temporary Vendor's License application should be consistent with the vendor application.
- 7. Submit the Temporary Vendor's License application with a copy of citizenship card with the vendor space application.
- 8. Return both applications by mail to P.O. Box 580, Okmulgee, OK 74447, email to sagee@muscgeenation.come or in person to the Redstick Gallery, 105 S. Grand Ave, Okmulgee.
